Dave Akins of Mayflower Sales will focus on some unique Life Safety products designed to address the concerns of behavioral health care institutions on helping to deter Door Suicide.

Accompanying Dave will be Ray Krispin of Marks USA who will discuss the Marks SS50 series Safety Lock in both mortise and tubular functions as well as the SS deadbolt series. These locks are widely used in psychiatric facilities. Additionally, he will discuss the new Marks hospital Push/Pull locksets which are now available.

Darren Weinstein, of P.J. Polke, will present a new and important patent-pending electronic monitoring device designed to detect attempted hangings off of doors.

The systems presented at this meeting cannot prevent a suicide, but act as deterrents and address the needs of all health care and correctional facilities.

The Postmaster General recently issued an official opinion declaring that "bump keys" fall under the definition of "locksmithing devices," which are considered to be non-mailability under current federal law. The law (39 USC 30 §3002a) makes it a crime to mail "locksmithing devices" to anyone other than a lock manufacturer or distributor, a bonafide locksmith, a bona fide re-possessor or a motor vehicle manufacturer or dealer.

Now, if an individual is caught mailing a "bump key" they could be fined up to \$1,000 or imprisoned up to one year, or both.
